Oz Elite Basketball Player Expectations

- Be ready to practice promptly at our start times. If needed, show up a few minutes early to get yourself ready.
- If you have to miss a practice, game, or are going to be late, please let your coach know in advance. A commitment to attend all possible training sessions and games is expected.
- Excel in the classroom. You will either pay the price now, or you'll pay a bigger price later! If you can't pass, you can't play.

- Respect of coaches, players and referees is expected at all times. Breaking of this rule will result in consequences determined by the OEB Director. Players are to listen and concentrate on what the coach says at all times.
- Players must also be able to accept constructive criticism without excuses.
- Players are to always do their best in practice and games to improve upon their level of play. We play as we practice; always give 110% when on the floor.
- Players must always put the team first. A player must accept decisions that are made for the good of the team.
 - Never Give Up! Winners never quit and quitters never win.
- Represent OEB program appropriately on the court, in the classroom, and in the community.
- **Understand that playing time is earned at practice - not guaranteed.**
 - **Players must not use profanity and shall behave appropriately.**
 - **Have a positive attitude and an eagerness to learn.**

The purpose of this document is to ensure that all parents/guardians of youth participants involved in the OEB Program are made aware of and are participants of the groups “No Nonsense Code of Conduct Agreement” involving parents and fans. OEB does not tolerate hostile, abusive and/or disruptive outbursts by coaches, parents, or fans. Failure to observe the parents Code of Conduct could result in forfeiture of your student-athletes participation with the OEBG and No Refunds will be given!

I hereby pledge to provide positive support, care, and encouragement for my student-athlete participating in OEB following this Parents' Code of Conduct:

I will refrain for a period of **24 hours** after any game from discussing with the coaches any issues concerning playtime or coaching strategies and I understand that these types of conversations should almost never occur. This is a OEBG Rule.



I do understand there is NO guaranteed playing time for my child.

As a Parent I will cheer and offer encouragement but I will refrain from being a "Coach in the Stands" and I understand that players who are looking to the stands for advice and direction usually find themselves on the bench looking to the stands.

Refrain from criticizing other player's efforts on the floor. Refrain from criticizing the officials because it usually hurts us and the players use it as an excuse for our losses.

- I will encourage good sportsmanship by demonstrating **positive support** for all players, coaches, and officials at every game, or practice.
- I will place the emotional and physical well being of my student-athlete and other players a head of my personal desire to win.
- I will insist that my student-athlete play in a safe and healthy environment.
 - I will support coaches and officials working with my child, in order to encourage a positive and enjoyable basketball experience for all.
 - I will demand a sports environment for my child that is free from drugs, tobacco and alcohol and will refrain from their use at youth basketball events.
- I will remember that my student-athlete's game of basketball is for youth - not adults.
 - I will do my very best to make the sport of basketball fun for my student-athlete.
- I will ask my student-athlete to treat other players, coaches, fans and officials with respect regardless of race, sex, creed or **ability**.
 - I will also treat with respect other players, coaches, fans and officials.

- I will help my student-athlete enjoy the basketball experience by doing whatever I can to be a respectful fan.
- As a parent and fan I will not harass, abuse, disrespect, or cause a disturbance against an opposing coach, player or official. I will remain committed to the Code of Conduct.

Oz Elite Basketball Sports Waiver and Release of Liability

In my absence, I authorize the representatives of OEB and or the coach of my (my student-athlete's) team to transport _____ to a hospital in case of injury or suspected injury during the times that the above named individual is participating in any event being played or to call for emergency rescue services should they be necessary.

I authorize the attending physician at the hospital to administer necessary emergency medical care to the above named individual upon his/her arrival at the hospital. I will accept responsibility for the payment of any and all treatment provided therein including emergency rescue services, etc.

I further understand the following issues: (1) that I am legally responsible for action of the above named individual including, but not limited to, any damage to private or public property caused by him/her; (2) that I am legally responsible for my own and/or my child's welfare and actions including personal needs and medical expenses; and, (3) that this waiver of liability shall remain in effect through.



Finally, I declare that my signature below shall serve as a waiver for all claims against Oz Elite Basketball Inc.; it's Board of Directors, volunteers, contracted workers, and the employees or agents thereof. I have read and fully understand the Waiver of Liability and Release provisions contained herein and understand the effect of the relinquishment of the rights, which I hereby waive.

**OZ ELITE BASKETBALL, INC. PARENTAL WAIVER, RELEASE OF
LIABILITY AND INDEMNIFICATION AGREEMENT FORM**

I, the undersigned, as the parent or legal guardian of the minor child named below, do hereby give my full consent and approval for my child to participate as a member of the OZ ELITE BASKETBALL, Inc. boys youth team.

I understand that there are certain risks of damages and injuries, including death, inherent in the practice and play of basketball, as well as in traveling in other related activities incidental to my child's participation, and I am willing to assume these risks on behalf of my child. These risks include, but are not limited to, those hazards associated with weather conditions, travel, playing conditions, equipment and other participants.

I understand that players diving on the floor is dangerous to my child and to other players and may result in serious injury or death.

I understand that the very nature of the game of basketball is hazardous and risky, including, but not limited to, the acts of running, jumping, stretching, diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to my child and to other players.

Further, I agree that in consideration for the right to allow my child to participate as a member of OZ ELITE BASKETBALL, Inc. and in consideration for permission to play on the facilities arranged for by the team:

1. On behalf of my child and myself, I do voluntarily elect to accept and solely assume all risks of injury incurred or suffered by my child (a) while practicing or playing as a member of the team, (b) while serving in a non-playing capacity as a team member during practice or play by other teams or by other players on my child's team, and (c) while on or upon the premises of any and all of the facilities arranged for by OZ ELITE BASKETBALL, Inc. for practice or play.

2. In addition to giving my full consent for my child's participation, I do hereby release, discharge and agree not to sue OZ ELITE BASKETBALL, Inc. and/or its officers, coaches, and team sponsors for any claim, damages, costs including attorney fees, or cause of action which I have or may in the future as a result of injuries or damages sustained or incurred by my child from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.

I hereby certify that my child is fully capable of participating in the designated sport and that my child is healthy and has no physical or mental disabilities or



infirmities that would restrict full participation in these activities, except as made known to coaches and officers of the team.

I further agree on behalf of myself and my child listed below, that I shall hold harmless and fully indemnify the parties hereby released from any and all claims, damages, costs including attorney fees, and causes of action which may arise from any cause of action made by me or by, through or on behalf of my child, even if the damages, injuries or death are caused in whole or in part by any of the persons or entities hereby released.

I ACKNOWLEDGE THAT I HAVE READ AND THAT I UNDERSTAND EACH AND EVERY ONE OF THE PROVISIONS IN THIS WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT AND AGREE TO ABIDE BY THEM.
